The EP Fundamentals curriculum is designed to support fellows during their first year of training in electrophysiology (EP). Commitment to attend each session of the seven month program is required.


By participating in the entire curriculum, attendees unlock the program's full value — building essential skills, growing confidence and forming lasting connections in EP.
